#### 11. New Business

- Waiver for liability. Bill Mitchell asked if the Park should have a waiver signed by all guests visiting the park. To be discussed further at a future meeting.
- Lottie Legros was asked by an owner if one of the nets in the tennis court could be lowered to pickleball height. There is a hook in the middle of each court on the ground. It is there to allow the net to be lowered the 2" to comply with the regulations for pickleball. Brian Lamb has lowered the left net. If tennis players want that court, they merely have to unhook the net.
- Lottie Legros was asked by an owner if a speed bump could be added to E Section. Brian Lamb will get back to Lottie.
- If you park a vehicle at your site you must park within your site lines, as per Section 8.17 of the Rules and Regulations. If you cannot accomplish this, then you must use the overflow parking lots. Projecting out onto or parking on roadways is not permitted.

## September 2022 Park Managers Report

- (1) The front loading washing machine in the lower laundry is still out of service, as well as 2 washers in the upper laundry. Also, we have 1 dryer in both upper and lower laundry that are not working. For now, please be mindful of the signage on the units.
- (2) The dog park fence has been stained. Staining other projects around the park is also almost completed.
- (3) The waterslide is now finished for this season.
- (4) The parts for the air compressor arrived last week and it is now back in operation in Angel Pond.
- (5) The demand on our water system this past Labor Day weekend was huge. We had one of our main pumps fail. It was replaced the next day. Water disruption to the park was minimal.
- (6) The second coating of Calcium chloride was applied to the roadways.
- (7) The main gate is not functioning at the present time. I will try to order parts from the manufacturer. If they are not available, I will have a machinist fabricate the necessary parts. The computer system is still working, so please continue to scan your pass as you enter. More diligence on observing persons following you in would be greatly appreciated.
- (8) This past long weekend there were no serious complaints from any site owners. It was very obvious throughout the days that people were having a great time.
