Never park on the road. **Parking Permits:** Vehicles will display a permit when parked outside a campsite. An email will be sent to owners when the permits are available for pickup.

Site Cleanup: All tarps, temporary covers, and covers of any kind placed over the roofs of Recreational Vehicle's, Sleeping Units, or other structures, shall be totally removed and neatly stored in/on the designated campsite by the last day on the May long weekend.

Every Shareholder shall complete a general cleanup of his/her designated campsite prior to June 1st of every camping season.

Pets: Campers are responsible to clean up after them. All dogs must be kept on a leash when outside of a campsite and secured within a campsite. This is for the safety of all the beloved pets in the park. There are 2 dog parks, where your pet can be off leash but must be supervised by the owner.
